CroCo-Meta is a Java implemented GUI which provides an easy way for the storage of meta-information (for Windows and Linux). It facilitates annotating meta information on the texts contained in a corpus, since the required data is presented in the form of input fields.

When running the executable file crocometa.bat/crocometa.sh, a standard form pops up in which the annotator can fill in or select for the appropriate entry. This means that the annotator does not need to work with XML files in which multiple embedding of elements may occur. Furthermore, the presetting of the possible entry choices makes the annotation process faster and diminishes the error rate.
